# **GIM Author/Reviewer Privacy Information**

## What data GIM Editorial Manager collects from Authors and Reviewers:

Your name, contact information, including your professional position and affiliation, potential financial conflict of interest disclosures, and various metadata about your manuscript, including the manuscript files themselves. This information is stored in the Editorial Manager database.

We consider your submission and the information contained in your manuscript and cover letter to be confidential information and will treat it as such. We do send submissions, including all author names, to external peer reviewers but request that they keep the information confidential. You may request withdrawal of your manuscript at any time by emailing <u>geneticsinmedicine@acmg.net</u>.

## How we use the data:

## For peer review and publication:

We use the data to perform internal editorial review and external peer review of your manuscript. If we publish your manuscript, your name, institutional affiliation, and much of the material you submit with the manuscript will be made public. This includes disclosure forms and any data sharing statements. We will also deposit an article, and associated forms, for you in a repository if so indicated by you at submission.

We may contact you and your individual coauthors with questions about your submitted manuscript.

## For transferring manuscripts:

If your manuscript is rejected for publication by GIM and you elect to have GIM transfer your manuscript to another journal, we will transfer your submitted manuscript and related files (possibly including external peer reviewer comments), your and your coauthors' names and contact information, and a copy of the rejection letter you receive from us. You may ask us to change the election of transfer at any time while your manuscript is being reviewed by GIM by emailing geneticsinmedicine@acmg.net. If you have elected transfer to another journal, the material will be automatically transferred once a decision is made by GIM to reject the manuscript. If you wish to withdraw your manuscript at that time, you will need to contact the destination journal. GIM is not liable in any way for any material transferred to another journal.

## For reviewers:

When submitting your review to GIM, you will be asked whether you want your comments and/or personal information transferred, should the authors of the rejected manuscript choose to transfer to another journal. You may ask us to change the election of transfer at any time while your manuscript is being reviewed by GIM by emailing <u>geneticsinmedicine@acmg.net</u>. However, once the article is transferred to another journal you will need to contact the destination journal. GIM is not liable in any way for any material transferred to another journal.

GIM publishes in print and/or on social media sites (e.g. Twitter and Facebook) a list of reviewers who have reviewed for us the previous year. Your name will be included unless you specifically opt-out by emailing geneticsinmedicine@acmg.net.

## Marketing:

We do not share our author and reviewer database with our marketing department

## Contacting you:

If you are an author, we will contact you from time to time while your manuscript is under review. If you are a reviewer, we may contact you from time to time to ask you to perform a review.

In addition, we may ask you to opt in (or opt out) of receiving surveys from GIM. These surveys help to gather information about your interaction with GIM as a reviewer or an author.
